EVERY VENDOR MUST BE SELF-SUFFICIENT. PERMITS WHERE APPLICABLE, TAX LICENSING AND COLLECTION WILL BE THE RESPONSIBILITY OF EACH VENDOR. APPLICATIONS ARE DUE BY **SEPTEMBER 15TH**; HOWEVER SPACES WILL BE ALLOCATED ON A FIRST PAID BASIS. FREE DRY CAMPING IS AVAILABLE TO VENDORS ON FRIDAY AND SATURDAY NIGHTS.
